UNIVERSAL SPACES FOR MANIFOLDS EQUIPPED WITH AN
INTEGRAL CLOSED k -FORM

HÔNG-VÂN LÊ

ABSTRACT. In this note we prove that any integral closed k -form ϕ^k , $k \geq 3$, on a m -dimensional manifold M^m , $m \geq k$, is the restriction of a universal closed k -form h^k on a universal manifold $U^{d(m,k)}$ as a result of an embedding of M^m to $U^{d(m,k)}$.

1. INTRODUCTION

Let a manifold M^m be equipped with a tensor of degree α^k and a manifold N^n equipped with a tensor β^k . Suppose that $n > m$. We want to know if there is an immersion $f: M^m \rightarrow N^n$ such that $f^*(\beta^k) = \alpha^k$. This problem has a long history, the Nash embedding theorem for (M^m, α^2) being a Riemannian manifold and (N^n, β^2) being the standard Euclidean space is one of most spectacular results in this field. Gromov in his seminal book [3] developed many methods for solving this problem.

In this note we apply the Gromov theory to obtain the existence of a universal space $U^{d(m,k)}$, equipped with an integral closed k -form h^k , $k \geq 3$, for any m -dimensional manifolds M^m , $m \geq k$, equipped with an integral closed k -form ϕ^k (Theorem 3.6). Theorem 3.6 is a generalization of Tischler's theorem [8] on the existence of a symplectic embedding from an integral symplectic manifold (M^{2n}, ω) to $\mathbb{C}P^n$ equipped with the standard Kähler symplectic form.

This note also contains an Appendix written in communication with Kaoru Ono which contains a new “soft” proof of a version Theorem 3.6 on the existence of a universal space for manifolds equipped with an integral closed k -form. Our soft proof does not use the Nash-Gromov implicit function theorem, but we do not get a C^0 -perturbation result as in Theorem 3.6.

2. H-PRINCIPLE AND NASH-GROMOV IMPLICIT FUNCTION THEOREM

In this section we briefly recall some important notions and results in the Gromov theory [3] which we shall use for our proof of Theorem 3.6.

Let V and W be smooth manifolds. We denote by $(V, W)^{(r)}$, $r \geq 0$, the space of r -jets of smooth mappings from V to W . We shall think of each map $f: V \rightarrow W$ as a section of the fibration $V \times W = (V, W)^{(0)}$ over V . Thus $(V, W)^{(r)}$ is a fibration over V , and we shall denote by p^r the canonical projection $(V, W)^{(r)}$ to V , and by p_r^s the canonical projection $(V, W)^{(s)} \rightarrow (V, W)^{(r)}$, for any $s > r$.

A section $s: V \rightarrow (V, W)^r$ is called *holonomic*, if s is the r -jet of some section $f: V \rightarrow (V, W)$.

We say that a differential relation $\mathcal{R} \subset (V, W)^{(r)}$ satisfies the *H-principle*, if every continuous section $\phi_0: V \rightarrow \mathcal{R}$ can be brought to a holonomic section ϕ_1 by a homotopy of sections $\phi_t: V \rightarrow \mathcal{R}$, $t \in [0, 1]$.

We say that a differential relation $\mathcal{R} \subset (V, W)^{(r)}$ satisfies the *H-principle C^0 -near a map* $f_0: V \rightarrow W$, if every continuous section $\phi_0: V \rightarrow \mathcal{R}$ which lies over f_0 , (i.e. $p_0^r \circ \phi_0 = f_0$) can be brought to a holonomic section ϕ_1 by a homotopy of sections $\phi_t: V \rightarrow \mathcal{R}_U$, $t \in [0, 1]$, for an arbitrary small neighborhood U of $f_0(V)$ in $V \times W$ [3, 1.2.2]. Here for an open set $U \subset V \times W$, we write

$$\mathcal{R}_U := (p_0^r)^{-1}(U) \cap \mathcal{R} \subset (V, W)^r.$$

The H-principle is called *C^0 -dense*, if it holds true C^0 -near every map $f: V \rightarrow W$.

We also define the *fine C^0 -topology* on the space $C^0(X)$ of continuous sections of a smooth fibration $X \rightarrow V$ by taking the sets $C^0(U) \subset C^0(X)$, U is open in X , as the basis for this topology. The *fine C^r -topology on $C^r(X)$* is induced by the fine C^0 -topology on $C^0(X^{(r)})$ using the embedding $C^r(X) \rightarrow C^0(X^{(r)})$.

Suppose we are given a differential relation $\mathcal{R} \subset (V, W)^{(r)}$. We define the *prolongation* $\mathcal{R}^k \subset (V, W)^{r+k}$ inductively. Let $\mathcal{R}^1 \subset (\mathcal{R}^{(r)})^{(1)}$ consist of the 1-jets of germs of C^1 -sections $V \rightarrow \mathcal{R}$. We put $\mathcal{R}^1 := \mathcal{R}^1 \cap X^{(r+1)} \subset (X^{(r)})^{(1)}$. Then repeat this and define $\mathcal{R}^k := (V, W)^{r+k} \cap (\mathcal{R}^{k-1})^1 \subset ((V, W)^{r+k-1})^1$. A C^{r+k} -solution of \mathcal{R} is a holonomic section of \mathcal{R}^k .

Fix an integer $k \geq r$ and denote by $\Phi(U)$ the space of C^k -solutions of \mathcal{R} over U for all open $U \subset V$. This set equipped with the natural restriction $\Phi(U) \rightarrow \Phi(U')$ for all $U' \subset U$ makes Φ a sheaf which we call the *solution sheaf* of \mathcal{R} over V . We shall say that Φ satisfies the *H-principle*, if \mathcal{R} satisfies the H-principle.

A sheaf Φ is called *flexible (microflexible)*, if the restriction map $\Phi(C) \rightarrow \Phi(C')$ is a fibration (microfibration) for all pair of compact subsets C and $C' \subset C$ in M . We recall that the map $\alpha: A \rightarrow A'$ is called *microfibration*, if the homotopy lifting property for a homotopy $\psi: P \times [0, 1] \rightarrow A'$ is valid only “micro”, i.e. there exists $\varepsilon > 0$ such that ψ can lift to a homotopy $\bar{\psi}: P \times [0, \varepsilon] \rightarrow A$.

2.1. H-principle and flexibility [3, 2.2.1.B]. *If V is a locally compact countable polyhedron (e.g. manifold), then every flexible sheaf over V satisfies the H-principle.*

One of Gromov’s methods to get the microflexibility of some sheaf is to exploit the Nash-Gromov implicit function theorem.

Let $X \rightarrow V$ be a smooth fibration and $G \rightarrow V$ be a smooth vector bundle over a manifold V . We denote by \mathcal{X}^α and \mathcal{G}^α respectively the spaces of C^α -sections of

the fibrations X and G for all $\alpha = 0, 1, \dots, \infty$. Let $\mathcal{D}: \mathcal{X}^r \rightarrow \mathcal{G}^0$ be a differential operator of order r . In other words the operator \mathcal{D} is given by a bundle map $\Delta: X^{(r)} \rightarrow G$, namely $\mathcal{D}(x) = \Delta \circ J_x^r$, where $J_x^r(v)$ denotes the r -jet of x at $v \in V$. We assume below that \mathcal{D} is a C^∞ -operator and so we have continuous maps $\mathcal{D}: \mathcal{X}^{\alpha+r} \rightarrow \mathcal{G}^\alpha$ for all $\alpha = 0, 1, \dots, \infty$.

Now we shall define the linearization of a differential operator \mathcal{D} . Let x be a C^α -section of a smooth vector bundle $X \rightarrow V$. Denote by Y_x the induced vector bundle $x^*(T_{vert}(X))$. For each $\beta \leq \alpha$ we denote by \mathcal{Y}_x^β the space of C^β -section $V \rightarrow Y_x$. The space \mathcal{Y}_x^α can be considered as the tangent space $T_x(\mathcal{X}^\alpha)$. Now we suppose that the fibration $X \rightarrow V$ does not have boundary. For $x \in \mathcal{X}^r$ the linearization $L_x: \mathcal{Y}_x^r \rightarrow \mathcal{G}^0$ of the operators \mathcal{D} at x is defined as follows. Let $y = \partial x_t / \partial t|_{t=0}$. Then

$$L_x(y) = L(x, y) = \frac{\partial}{\partial t}|_{t=0} \mathcal{D}(x_t).$$

We say that the operator \mathcal{D} is *infinitesimal invertible over a subset \mathcal{A}* in the space of sections $x: V \rightarrow X$ if there exists a family of linear differential operators of certain order s , namely $M_x: \mathcal{G}^s \rightarrow \mathcal{Y}_x^0$, for $x \in \mathcal{A}$, such that the following three properties are satisfied.

- (1) There is an integer $d \geq r$, called *the defect of the infinitesimal inversion M* , such that \mathcal{A} is contained in \mathcal{X}^d , and furthermore, $\mathcal{A} = \mathcal{A}^d$ consists exactly of C^d -solutions of an open differential relation $A \subset X^{(d)}$. In particular, the sets $\mathcal{A}^{\alpha+d} = \mathcal{A} \cap \mathcal{X}^{\alpha+d}$ are open in $\mathcal{X}^{\alpha+d}$ in the respective fine $C^{\alpha+d}$ -topology for all $\alpha = 0, 1, \dots, \infty$.
- (2) The operator $M_x(g) = M(x, g)$ is a (non-linear) differential operator in x of order s . Moreover the global operator

$$M: \mathcal{A}^d \times \mathcal{G}^s \rightarrow \mathcal{J}^0 = T(\mathcal{X}^0)$$

is a differential operator, that is given by a C^∞ -map $A \oplus G^{(s)} \rightarrow T_{vert}(X)$.

- (3) $L_x \circ M_x = Id$ that is

$$L(x, M(x, g)) = g \text{ for all } x \in \mathcal{A}^{d+r} \text{ and } g \in \mathcal{G}^{r+s}.$$

Now let \mathcal{D} admit over an open set $\mathcal{A} = \mathcal{A}^d \subset \mathcal{X}^d$ an infinitesimal inversion M of order s and of defect d . For a subset $\mathcal{B} \subset \mathcal{X}^0 \times \mathcal{G}^0$ we put $\mathcal{B}^{\alpha,\beta} := \mathcal{B} \cap (\mathcal{X}^\alpha \times \mathcal{G}^\beta)$. Let us fix an integer σ_0 which satisfies the following inequality

$$(*) \quad \sigma_0 > \bar{s} = \max(d, 2r + s).$$

Finally we fix an arbitrary Riemannian metric in the underlying manifold V .

2.2. Nash-Gromov implicit function theorem [3, 2.3.2]. *There exists a family of sets $\mathcal{B}_x \subset \mathcal{G}^{\sigma_0+s}$ for all $x \in \mathcal{A}^{\sigma_0+r+s}$, and a family of operators $\mathcal{D}_x^{-1}: \mathcal{B}_x \rightarrow \mathcal{A}$ with the following five properties.*

- (1) Neighborhood property: *Each set \mathcal{B}_x contains a neighborhood of zero in the space \mathcal{G}^{σ_0+s} . Furthermore, the union $\mathcal{B} = \{x\} \times \mathcal{B}_x$ where x runs over $\mathcal{A}^{\sigma_0+r+s}$, is an open subset in the space $\mathcal{A}^{\sigma_0+r+s} \times \mathcal{G}^{\sigma_0+s}$.*
- (2) Normalization property: $\mathcal{D}_x^{-1}(0) = x$ for all $x \in \mathcal{A}^{\sigma_0+r+s}$.

- (3) Inversion property: $\mathcal{D} \circ \mathcal{D}_x^{-1} - \mathcal{D}(x) = Id$, for all $x \in \mathcal{A}^{\sigma_0+r+s}$, that is
- $$\mathcal{D}(\mathcal{D}_x^{-1}(g)) = \mathcal{D}(x) + g,$$

for all pairs $(x, g) \in \mathcal{B}$.

- (4) Regularity and continuity: If the section $x \in \mathcal{A}$ is C^{η_1+r+s} -smooth and if $g \in \mathcal{B}_x$ is C^{σ_1+s} -smooth for $\sigma_0 \leq \sigma_1 \leq \eta_1$, then the section $\mathcal{D}_x^{-1}(g)$ is C^σ -smooth for all $\sigma < \sigma_1$. Moreover the operator $\mathcal{D}^{-1}: \mathcal{B}^{\eta_1+r+s, \sigma_1+s} \rightarrow \mathcal{A}^\sigma$, $\mathcal{D}^{-1}(x, g) = \mathcal{D}_x^{-1}(g)$, is jointly continuous in the variables x and g . Furthermore, for $\eta_1 > \sigma_1$, the section $\mathcal{D}^{-1}: \mathcal{B}^{\eta_1+r+s, \sigma_1+s} \rightarrow \mathcal{A}^{\sigma_1}$ is continuous.
- (5) Locality: The value of the section $\mathcal{D}_x^{-1}(g): V \rightarrow X$ at any given point $v \in V$ does not depend on the behavior of x and g outside the unit ball $B_v(1)$ in V with center v , and so the equality $(x, g)|_{B_v(1)} = (x', g')|_{B_v(1)}$ implies $(\mathcal{D}_x^{-1}(g))(v) = (\mathcal{D}_{x'}^{-1}(g'))(v)$.

2.3. Corollary (Implicit Function Theorem). For every $x_0 \in \mathcal{A}^\infty$ there exists fine $C^{\bar{s}+s+1}$ -neighborhood \mathcal{B}_0 of zero in the space of $\mathcal{G}_{\bar{s}+s+1}$, where $\bar{s} = \max(d, 2r + s)$, such that for each $C^{\sigma+s}$ -section $g \in \mathcal{B}_0$, $\sigma \geq \bar{s} + 1$, the equation $\mathcal{D}(x) = \mathcal{D}(x_0) + g$ has a C^σ -solution.

Finally we shall show a large class of microflexible solution sheafs Φ by using the Nash-Gromov implicit function theorem.

Let us fix a C^∞ -section $g: V \rightarrow G$ and we call a C^∞ -germ $x: \mathcal{O}p(v) \rightarrow X$, $v \in V$, an infinitesimal solution of order α of the equation $\mathcal{D}(x) = g$, if at the point v the germ $g' = g - \mathcal{D}(x)$ has zero α -jet, i.e. $J_{g'}^\alpha(v) = 0$. We denote by $\mathcal{R}^\alpha(\mathcal{D}, g) \subset X^{(r+\alpha)}$ the set of all jets represented by these infinitesimal solutions of order α over all points $v \in V$. Now we recall the open set $A \subset X^{(d)}$ defining the set $\mathcal{A} \subset X^{(d)}$, and for $\alpha \geq d - r$ we put

$$\mathcal{R}_\alpha = \mathcal{R}_\alpha(A, \mathcal{D}, g) = A^{r+\alpha-d} \cap \mathcal{R}^\alpha(\mathcal{D}, g) \subset X^{(r+\alpha)},$$

where $A^{r+\alpha-d} = (p_d^{r+\alpha})^{-1}(A)$ for $p_d^{r+\alpha}: X^{r+\alpha} \rightarrow X^d$.

A $C^{r+\alpha}$ -section $x: V \rightarrow X$ satisfies \mathcal{R}_α , iff $\mathcal{D}(x) = g$ and $x \in \mathcal{A}$.

Now we set $\mathcal{R} = \mathcal{R}_{d-r}$ and denote by $\Phi = \Phi(\mathcal{R}) = \Phi(A, \mathcal{D}, g)$ the sheaf of C^∞ -solutions of \mathcal{R} .

2.4. Microflexibility of the sheaf of solutions and the Nash-Gromov implicit functions [3, 2.3.2.D’]. The sheaf Φ is microflexible.

To relate the microflexibility and the flexibility (and hence to get the H-principle) Gromov introduced the notion of manifolds sharply movable by acting diffeotopies. We refer the reader to [3, 2.3.2] for detailed information.

3. UNIVERSAL SPACE FOR INTEGRAL CLOSED K-FORMS ON M-DIMENSIONAL MANIFOLDS

Suppose that $m \geq k \geq 3$. In this section we shall show that any integral closed k -form ϕ^k on a m -dimensional smooth manifold M^m can be induced from

a universal closed k -form h^k on a universal manifold $U^{d(m,k)}$ by an embedding M^m to a universal space $(U^{d(m,k)}, h^k)$, see Theorem 3.6.

Our definition of the universal space $(U^{d(m,k)}, h^k)$ is based on the work of Dold and Thom [1] as well as the idea of Gromov [4] to reduce this problem to the case that ϕ^k is an exact k -form.

Let $SP^q(X)$ be the q -fold symmetric product of a locally compact, paracompact Hausdorff pointed space $(X, 0)$, i.e. $SP^q(X)$ is the quotient space of the q -fold Cartesian $(X^q, 0)$ over the permutation group σ_q . We shall denote by $SP(X, 0)$ the inductive limit of $SP^q(X)$ with the inclusion

$$X = SP^1(X) \xrightarrow{i_1} SP^2(X) \xrightarrow{i_2} \dots \rightarrow SP^q(X) \xrightarrow{i_q} \dots,$$

where

$$SP^q(X) \xrightarrow{i_q} SP^{q+1}(X): [x_1, x_2, \dots, x_q] \mapsto [0, x_1, x_2, \dots, x_q].$$

Equivalently we can write

$$SP(X, 0) = \sum_q SP^q(X) / ([x_1, x_2, \dots, x_q] \sim [0, x_1, x_2, \dots, x_q]).$$

So we shall also denote by i_q the canonical inclusion $SP^q(X) \rightarrow SP(X, 0)$.

3.1. Theorem (see [1, Satz 6.10]). *There exist natural isomorphisms $j: H_q(X, \mathbb{Z}) \rightarrow \pi_q(SP(X, 0))$ for $q > 0$.*

3.2. Corollary ([1]). *The space $SP(S^n, 0)$ is the Eilenberg-McLane complex $K(\mathbb{Z}, n)$.*

Now let τ^k be the generator of $H^k(SP(S^k, 0), \mathbb{Z})$ and by abusing notations we also denote by τ^k the restriction of the generator τ^k to any subspace $i_q(SP^q(S^k)) \subset SP(S^k, 0)$. The following lemma shows that we can replace a classifying map from $(M^m, [\phi^k])$ to $(SP(S^k, 0), \tau^k)$ by a map from $(M^m, [\phi^k])$ to $(SP^{\lfloor \frac{m-k}{2} \rfloor + 1}(S^k), \tau^k)$.

3.3. Lemma. *Let $[\phi^k] \in H^k(M^m, \mathbb{Z})$. Then there exists a continuous map f from M^m to $(SP^{\lfloor \frac{m-k}{2} \rfloor + 1}(S^k))$ such that $f^*(\tau^k) = [\phi^k]$.*

Proof. Let f_0 be a classifying map from M^m to $SP(S^k, 0)$ such that $f_0^*(\tau^k) = \alpha$. Denote by K^i the i -dimensional skeleton of $SP(S^k, 0)$ and by $\bar{\tau}^k$ the restriction of τ^k to K^m . Then we know that f_0 is homotopic equivalent to a continuous map $f_1: M^m \rightarrow K^m$ such that $f_1^*(\bar{\tau}^k) = [\phi^k]$. To prove Lemma 3.3 it suffices to find a map $g: K^m \rightarrow SP^{\lfloor \frac{m-k}{2} \rfloor + 1}(S^k)$ such that $g^*(\tau^k) = \bar{\tau}^k$. Then the map $f = g \circ f_1$ satisfies the condition of Lemma 3.3.

We observe that $K^{k+1} = K^k$ consists of the sphere S^k . If $m = k$ or $m = k + 1$, then g can be chosen as the identity map. Now suppose that $m \geq k + 2$. The following identity [2, (12.12)],

$$\pi_i(SP^m(X)) = H_i(X) \quad \text{for } i < k + 2n - 1, n > 1,$$

if X is connected and $H_i(X) = 0$ for $0 < i < k, k > 1$, implies that

$$\pi_i(SP^{\lfloor \frac{m-k}{2} \rfloor + 1}(S^k)) = 0 \quad \text{for } k + 1 \leq i \leq m - 1.$$

Using the obstruction theory we obtain a map $g : K^m \rightarrow SP^{[\frac{m-k}{2}]+1}(S^k)$ extending the inclusion map $K^k = S^k \rightarrow SP^{[\frac{m-k}{2}]+1}(S^k)$. Clearly the map g satisfies the required property that $g^*(\tau^k) = \bar{\tau}^k$. \square

Since $SP^{[\frac{m-k}{2}]+1}(S^k)$ has a finite simplicial decomposition we can apply the Thom construction in [7, III.2] where Thom showed that any finite m -dimensional polyhedron K^m can be embedded in a compact $(2m + 1)$ -dimensional manifold M^{2m+1} such that K^m is a retract of M^{2m+1} . As a result we get the following

3.4. Lemma. *The space $SP^{[\frac{m-k}{2}]+1}(S^k)$ can be embedded into a compact smooth manifold $\mathcal{M}^{s(m,k)}$, $s(m, k) = 2[\frac{m-k}{2}] + 3$, such that (the image of) $SP^{[\frac{m-k}{2}]+1}(S^k)$ is a retract of $\mathcal{M}^{s(m,k)}$. \square*

Let us denote also by τ^k the pull back of the universal class τ^k from $SP^{[\frac{m-k}{2}]+1}(S^k)$ to $\mathcal{M}^{s(m,k)}$ and let α^k be any differential form representing τ^k on $\mathcal{M}^{s(m,k)}$.

Let β_N^k be the following k -form on $\mathbb{R}^{kN} = \bigoplus_{j=1}^N \mathbb{R}_j^k$ with coordinates x_j^i , $1 \leq i \leq k$, $1 \leq j \leq N$,

$$\beta_N^k = dx_1^1 \wedge dx_1^2 \wedge \dots \wedge dx_1^k + \dots + dx_N^1 \wedge dx_N^2 \wedge \dots \wedge dx_N^k.$$

We put for $l \geq k \geq 3$

$$\begin{aligned} \delta(l, k) := & (l - 1) + \frac{k - 1}{2} \left(2 + \left[\frac{l - 2}{k - 1} \right] \right) \left(\left[\frac{l - 2}{k - 1} \right] - 1 \right) + \left[\frac{l - 1}{k - 1} \right] \\ (3.5.1) \quad & \times \left(1 + ((l - 1) \bmod (k - 1)) \right). \end{aligned}$$

Here we set

$$(3.5.2) \quad i \bmod (k - 1) := i - (k - 1) \cdot [i / (k - 1)].$$

Set

$$(3.5.3) \quad d(m, k) := s(m, k) + k \left(\delta(2m + 1, k) + (m + 1) \binom{m+1}{k} \right).$$

Now we state the main theorem of this section. Let

$$(U^{d(m,k)}, h^k) = (\mathcal{M}^{s(m,k)} \times \mathbb{R}^{kN}, \alpha^k \oplus \beta_N^k),$$

with $N = \delta(2m + 1, k) + (m + 1) \binom{m+1}{k}$.

3.6. Theorem. *Suppose that ϕ^k is an integral closed k -form on a smooth manifold M^m . Then there exists an embedding $f : M^m \rightarrow (U^{d(m,k)}, h^k)$ such that $f^*(h^k) = \phi^k$. Moreover for any given map $\tilde{f} : M^m \rightarrow (U^{d(m,k)}, h^k)$ such that $\tilde{f}^*[h^k] = [\phi^k]$ there exists a C^0 -close to \tilde{f} embedding $f : M^m \rightarrow U^{d(m,k)}$ such that $f^*(h^k) = \phi^k$.*

Proof of Theorem 3.6. Using Lemma 3.3 and Lemma 3.4 we see that the first statement of Theorem 3.6 follows from the second statement of Theorem 3.6. Furthermore we shall reduce the second statement to an immersion problem for exact 3-forms as follows. Denote by $\tilde{f}_1 : M^m \rightarrow \mathcal{M}^{s(m,k)}$ the projection of \tilde{f} to the first factor. Then we have $\tilde{f}_1^*(\tau^k) = [\phi^k] \in H^k(M^m, \mathbb{Z})$. Let

$$g = \phi - \tilde{f}_1^*(\alpha).$$

Clearly g is an exact k -form on M^m . We can also assume that \tilde{f}_1 is an embedding by perturbing this map a little, if necessary. Thus the second statement of Theorem 3.6 is a corollary of the following proposition.

3.7. Proposition. *For any given map $f_0: M^m \rightarrow \mathbb{R}^{kN}$ there is a C^0 -close to f_0 immersion $f_3: M^m \rightarrow (\mathbb{R}^{kN}, \beta_N^k)$ such that $f_3^*(\beta_N^k) = g$ for any exact k -form g .*

We shall apply the Gromov H-principle for immersion of differential forms to prove Proposition 3.7. Gromov extended the Nash idea to add some regularity for an immersion in order to apply the implicit function theorem and then using 2.4 to get the H-principle for the isometric immersion. Finally using the H-principle we shall get immersion f_3 required in Proposition 3.7.

Let h be a smooth differential k -form on a manifold W . Denote by $I_{h(w)}$ a linear homomorphism

$$I_{h(w)}: T_w W \rightarrow \Lambda^{k-1}(T_w W)^*, X \mapsto X \lrcorner h.$$

A subspace $T \subset T_w W$ is called $h(w)$ -regular, if the composition of $I_{h(w)}$ with the restriction homomorphism $r: \Lambda^{k-1}(T_w W)^* \rightarrow \Lambda^{k-1}(T)^*$ sends $T_w W$ onto $\Lambda^{k-1}(T)^*$.

An immersion $f: V \rightarrow W$ is called h -regular, if for all $v \in V$ the subspace $Df(T_v V)$ is $h(f(v))$ -regular.

Proof of Proposition 3.7. Roughly speaking, we add the condition of β_N^k -regularity to the isometry property (i.e. $f_3^*(\beta_N^k) = g$) and extend this equation for mappings also denoted by f_3 from the manifold $M^{m+1} = M^m \times (-1, 1)$ provided with a form $g \oplus 0$, denoted also by g , to the space $(\mathbb{R}^{kN}, \beta_N^k)$. Our Proposition 3.10 states that the solution sheaf of this extended equation restricted to $M^m \subset M^{m+1}$ satisfies the H-principle. In fact, this statement is a consequence of Theorem 3.4.1.B' in [Gromov1986]. So essentially we re-expose the Gromov proof of Theorem 3.4.1.B', and we try to make Gromov's argument more transparent. Now to prove the existence of a β_N^k -regular isometric immersion f_3 which is C^0 -close to a given map f_0 , it suffices to find a section of this extended differential relation which lies over f_0 (Proposition 3.12). That is only the new ingredient in our proof of Proposition 3.7.

Now we are going to define our extended differential relation. Let us denote also by f_0 a map $M^{m+1} \rightarrow (\mathbb{R}^{kN}, \beta_N^k)$ extending a given map $f_0: M^m \rightarrow \mathbb{R}^{kN}$. We denote by F_0 the corresponding section of the bundle $M^{m+1} \times \mathbb{R}^{kN} \rightarrow M^{m+1}$, i.e. $F_0(v) = (v, f_0(v))$. Denote by $\Gamma_0 \subset M^{m+1} \times \mathbb{R}^{kN}$ the graph of f_0 (i.e. it is the image of F_0), and let $p^*(g)$ and $p^*(\beta_N^k)$ be the pull-back of the forms g and β_N^k to $M^{m+1} \times \mathbb{R}^{kN}$ under the obvious projection. Take a small neighborhood $Y \supset \Gamma_0$ in $M^{m+1} \times \mathbb{R}^{kN}$. Since β_N^k and g are exact forms we get

$$p^*(\beta_N^k) - p^*(g) = d\hat{\beta}_N$$

for some smooth $(k-1)$ -form $\hat{\beta}_N$ on Y .

Our next observation is

3.8. Lemma. *Suppose that a map $F: M^{m+1} \rightarrow Y$ corresponds to a β_N^k -regular immersion $f: M^{m+1} \rightarrow \mathbb{R}^{kN}$. Then F is a $d\hat{\beta}_N^k$ -regular immersion.*

Proof. We need to show that for all $y = F(z) \in Y$, $z \in M^{m+1}$, the composition ρ of the maps

$$T_y Y \xrightarrow{I_{p^*(\beta_N^k) - p^*(g)}} \Lambda^{(k-1)} T_y Y \rightarrow \Lambda^{(k-1)} (dF(T_{(z)}(M^{m+1})))$$

is onto. This follows from the consideration of the restriction of ρ to the subspace $S \subset T_y Y$ which is tangent to the fiber \mathbb{R}^{kN} in $M^{m+1} \times \mathbb{R}^{kN} \supset Y$. \square

Now for a map $d\hat{\beta}_N$ -regular map $F: M^{m+1} \rightarrow Y$ and a $(k-2)$ -form ϕ on M^{m+1} we set

$$(3.9) \quad \mathcal{D}(F, \phi) := F^*(\hat{\beta}_N) + d\phi.$$

With this notation the map $f: M^{m+1} \rightarrow \mathbb{R}^{kN}$ corresponding to $F: M^{m+1} \rightarrow Y$ satisfies

$$f^*(\beta_N^k) = F^*(p^*(\beta_N^k)) = g + F^*(d\hat{\beta}_N) = g + d\mathcal{D}(F, \phi),$$

for any ϕ . Since the space of $(k-2)$ -forms ϕ is contractible, it follows that the space of $d\hat{\beta}_N$ -regular sections $F: M^{m+1} \rightarrow Y$ for which

$$(3.9.1) \quad f^*(\beta_N^k) = g + dg_1$$

for a given $(k-1)$ -form g_1 has the same homotopy type as the space of solutions to the equation

$$\mathcal{D}(F, \phi) = g_1.$$

In particular the equation $f_3^*(\beta_N^k) = g$ reduces to the equation $\mathcal{D}(F, \phi) = 0$ in so far as the unknown map f_3 is C^0 -close to f_0 (so that its graph lies inside Y).

We define by $\tilde{\Phi}_{\text{reg}}$ the solution sheaf of the equation (3.9) whose component F is $d\hat{\beta}_N$ -regular.

3.10. Proposition. *The restriction of the solution sheaf $\tilde{\Phi}_{\text{reg}}$ to M^m satisfies the H-principle. Hence the solution sheaf of β_N^k -regular isometric immersions $f: (M^{m+1}, g) \rightarrow (\mathbb{R}^{kN}, \beta_N^k)$ such that $F(M^{m+1}) \subset Y$ restricted to M^m also satisfies the H-principle.*

Before proving this Proposition we shall prove the following

3.11. Lemma. *The differential operator \mathcal{D} is infinitesimal invertible at those pairs (F, ϕ) for which the underlying map f is a β_N^k -regular immersion.*

Proof. The linearization $L_{(F, \phi)} \mathcal{D}$ acts on the space of couples $(V, \tilde{\phi})$ where V is a section of $f^*(T_* \mathbb{R}^{kN})$ (a vector field on \mathbb{R}^{kN} along the corresponding map f) and $\tilde{\phi}$ is a $(k-2)$ -form on M^{m+1} as follows

$$(3.11.1) \quad L_{(F, \phi)} \mathcal{D}(V, \tilde{\phi}) = \mathcal{L}_V \hat{\beta}_N + d\tilde{\phi} = V \rfloor d\hat{\beta}_N + d(V \rfloor \hat{\beta}_N) + d\tilde{\phi}.$$

By Lemma 3.8 the map F is a $d\hat{\beta}_N$ -regular immersion. Hence the equation for V

$$(3.11.2) \quad F^*(V \rfloor d\hat{\beta}_N) = \tilde{g},$$

is solvable for all $(k-1)$ -form \tilde{g} on M^{m+1} . Now we set:

$$(3.11.3) \quad \tilde{\phi} := F^*(V \rfloor \hat{\beta}_N)$$

Clearly every couple $(V, \tilde{\phi})$ satisfying (3.11.2) and (3.11.3) is a solution of the equation $L_{(F,\phi)}\mathcal{D}(V, \tilde{\phi}) = \tilde{g}$ for any given $(k - 1)$ -form \tilde{g} . \square

Proof of Proposition 3.10. Taking into account Lemma 3.11 and 2.2 (Nash implicit function theorem), 2.4 (Nash implicit function theorem implies the microflexibility) we get the microflexibility of $\tilde{\Phi}_{\text{reg}}$. Next we use the Gromov observation [Gromov1986, 3.4.1.B'] that M^m is a sharply movable submanifold by acting diffeotopies in M^{m+1} which implies that the restriction of $\tilde{\Phi}_{\text{reg}}$ to M^m is flexible. Hence we get the first statement of Proposition 3.10 immediately. The second statement follows by a remark above relating (3.9) and (3.9.1). \square

Completion of the proof of Proposition 3.7. Suppose we are given a map $f_0: M^m \rightarrow \mathbb{R}^{kN}$. Since M^m is a deformation retract of M^{m+1} the map f_0 extends to a map $f: M^{m+1} \rightarrow \mathbb{R}^{kN}$.

For each $z \in M^m$ we denote by $\text{Mono}((T_z M^{m+1}, g), (T_{f(z)} \mathbb{R}^{kN}, \beta_N^k))$ the set of all monomorphisms $\rho: T_z M^{m+1} \rightarrow T_{f(z)} \mathbb{R}^{kN}$ such that the restriction of $\beta_N^k(\rho(z))$ to $Df(T_z M^{m+1})$ is equal to $(Df^{-1})^*g$.

3.12. Proposition. *There exists a section s of the fibration $\text{Mono}((TM^{m+1}, g), f^*(T\mathbb{R}^{kN}, \beta_N^k))$ such that $s(z)(T_z M^{m+1})$ is β_N^k -regular subspace for all $z \in M^m$.*

Proof. The proof of Proposition 3.12 consists of 3 steps.

Step 1. We consider TM^{m+1} and $M^m \times \mathbb{R}^{kN}$ as vectors bundles over the same base M^m . We shall show the existence of a section $s_1 \in \text{Mono}(TM^{m+1}, M^m \times \mathbb{R}^{kN})$ such that the image $s_1(TM^{m+1})$ is a β_N^k -regular sub-bundle of dimension $(m + 1)$ in $M^m \times \mathbb{R}^{kN}$. To save notations we also denote β_N^k by β^k .

3.13. Lemma. *For each given $l \geq k \geq 3$ there there exists a l -dimensional subspace V^l in \mathbb{R}^{kN} such that V^l is β^k -regular subspace, provided that $N \geq \delta(l, k)$.*

Proof. We shall construct a linear embedding $f^l: V^l \rightarrow \mathbb{R}^{kN}$ whose image satisfies the condition of Lemma 3.13. We work in opposite way, i.e. for each l we shall find a number $\delta(l, k)$ and an embedding $f: V^l \rightarrow \mathbb{R}^{k\delta(l,k)} = \bigoplus_{j=1}^{\delta(l,k)} \mathbb{R}^k$ and f can be written as

$$f := f^l = (f_1^l, f_2^l, \dots, f_{\delta(l,k)}^l), \quad f_j^l: V^l \rightarrow \mathbb{R}^k, j = \overline{1, \delta(l, k)},$$

such that f satisfies Lemma 3.13 with $\delta(l, k) = N$. Clearly the embedding $V^l \rightarrow V^{k\delta(l,k)} \rightarrow \mathbb{R}^{kN}$ also satisfies the condition of Lemma 3.13 for all $N \geq \delta(l, k)$. We shall show that our number $\delta(l, k)$ defined in this way is equal to that one defined by (3.5.1).

We can assume that $V^k \subset V^{k+1} \subset \dots \subset V^l$ is a chain of subspaces in V^l which is generated by some vector basis (e_1, \dots, e_l) in V^l . We denote by (e_1^*, \dots, e_l^*) the dual basis of $(V^l)^*$. By construction, the restriction of (e_1^*, \dots, e_l^*) to V^i is the dual basis of $(e_1, \dots, e_i) \in V^i$. For the sake of simplicity we shall denote the restriction of any v_j^* to these subspaces also by v_j^* (if the restriction is not zero).

We shall construct f_i^l inductively on the dimension l of V^l such that the following condition holds for all $k \leq i \leq l$

$$(3.14) \quad \langle (f_1^l)^*(\Lambda^{k-1}(\mathbb{R}_1^k)), (f_2^l)^*(\Lambda^{k-1}(\mathbb{R}_2^k)), \dots, (f_{\delta(i,k)}^l)^*(\Lambda^{k-1}(\mathbb{R}_{\delta(i,k)}^{k-1})) \rangle_{\otimes \mathbb{R}} \\ = \Lambda^{k-1}(V^i)^*.$$

The condition (3.14) implies that

$$I_{\beta^k}(\mathbb{R}^{k\delta(l,k)}) = \Lambda^{k-1}(V^i)^*,$$

so $f^i(V^i)$ is β^k -regular. For $l = k$ we can take $f_1^k = \text{Id}$, and $\delta(k, k) = 1$. Suppose that $(f_1^i, \dots, f_{\delta(i,k)}^i)$ are already constructed for our map

$$f^i = (f_1^i, \dots, f_{\delta(i,k)}^i) : V^i \rightarrow \mathbb{R}_1^k \times \dots \times \mathbb{R}_{\delta(i,k)}^k.$$

We shall construct map f^{i+1} as follows. We set for $j \leq \delta(i, k)$

$$f_j^{i+1}(e_p) = f_j^i(e_p) \quad \text{if } 1 \leq p \leq i, \\ f_j^{i+1}(e_{i+1}) = 0.$$

To find f_j^{i+1} , $\delta(i, k) + 1 \leq j \leq \delta(i+1, k)$, so that (3.14) holds for the next induction step $(i+1)$, it suffices to find linear maps $f_{\delta(i,k)+1}^{i+1}, \dots, f_{\delta(i+1,k)}^{i+1}$ with the following property

$$(3.15) \quad \langle (f_{\delta(i)+1}^{i+1})^* \Lambda^{k-1}(\mathbb{R}_{\delta(i,k)+1}^k)^*, \dots, (f_{\delta(i+1,k)}^{i+1})^* \Lambda^{k-1}(\mathbb{R}_{\delta(i+1,k)}^k)^* \rangle_{\otimes \mathbb{R}} \\ \supset \Lambda^{k-1}(V^i)^* \wedge e_{i+1}^*.$$

We shall proceed as follows. Set $\delta(i+1, k) := \delta(i, k) + \lfloor \frac{i}{k-1} \rfloor + 1$. Choose for any $1 \leq j \leq \delta(i+1, k)$ a basic (w_j^i) , $1 \leq i \leq k$, of the space \mathbb{R}_j^k . We let

$$f_j^{i+1}(e_{i+1}) = w_j^1 \in \mathbb{R}_j^k, \quad \text{if } j \geq \delta(i, k) + 1, \\ f_{\delta(i,k)+1}^{i+1}(e_1) = w_{\delta(i,k)+1}^2, \quad f_{\delta(i,k)+1}^{i+1}(e_2) = w_{\delta(i,k)+1}^3, \dots, f^{i+1}(e_{k-1}) = w_{\delta(i,k)+1}^k, \\ f_{\delta(i,k)+2}^{i+1}(e_k) = w_{\delta(i,k)+2}^2, \quad f_{\delta(i,k)+2}^{i+1}(e_{k+1}) = w_{\delta(i,k)+2}^3, \dots, f^{i+1}(e_{2(k-1)}) = w_{\delta(i,k)+2}^k, \\ \vdots \\ f_{\delta(i+1,k)}^{i+1}(e_i) = w_{\delta(i+1,k)}^{i \bmod (k-1)}.$$

It is easy to see that the constructed map f^{i+1} satisfies (3.15) and hence also (3.14). Now using the identity the $\delta(i + 1) - \delta(i) = \lfloor \frac{i}{k-1} \rfloor + 1$ we get

$$\begin{aligned} \delta(l, k) &= 1 + (l - k) + \sum_{i=k}^{l-1} \left\lfloor \frac{i}{k-1} \right\rfloor \\ &= (l - 1) + 2(k - 1) + 3(k - 1) + \dots + \left\lfloor \frac{l-2}{k-1} \right\rfloor (k - 1) + \left\lfloor \frac{l-1}{k-1} \right\rfloor \\ &\quad \times ((l - 1) \bmod (k - 1)) + 1) \\ &= (l - 1) + \frac{k - 1}{2} \left(2 + \left\lfloor \frac{l-2}{k-1} \right\rfloor \right) \left(\left\lfloor \frac{l-2}{k-1} \right\rfloor - 1 \right) + \left\lfloor \frac{l-1}{k-1} \right\rfloor \\ &\quad \times \left(1 + ((l - 1) \bmod (k - 1)) \right). \end{aligned}$$

□

We shall consider $M^m \times V^{2m+1}$ as a sub-bundle of $M^m \times \mathbb{R}^{\delta(2m+1,k)}$ over M^m . Next we shall find a section s_1 for Step 1 by requiring that s_1 is a section of the bundle $\text{Mono}(TM^{m+1}, M^8 \times V^v)$ of all fiber mono-morphisms from TM^{m+1} to $M^m \times V^v$. This section exists, since the fiber $\text{Mono}(T_x M^{m+1}, \mathbb{R}^v)$ is homotopic equivalent to $SO(2m + 1)/SO(m)$ which has all homotopy groups π_j vanishing, if $j \leq (m - 1)$. This completes the Step 1.

Step 2. Once a section s_1 in step 1 is specified we put the following form g_1 on $TM^{m+1}_{|M^m}$:

$$g_1 = g - s_1^*(\beta).$$

In this step we show the existence of a section s_2 of the fibration $\text{Hom}((TM^{m+1}, g_1), (M^m \times \mathbb{R}^{k \cdot (m+1) \cdot \binom{m+1}{k}}, \beta^k))$ over M^m . Here we consider $(M^m \times \mathbb{R}^{k \cdot (m+1) \cdot \binom{m+1}{k}}, \beta^k)$ as a fibration over M^m and equipped with the k -form β^k on the fiber $\mathbb{R}^{k \cdot (m+1) \cdot \binom{m+1}{k}}$. We do not require that s_2 is a monomorphism.

Using the Nash trick [5] (see also the proof of Proof of Theorem B.1 below) we can find a finite number of open coverings $U_i^j, j = \overline{1, (m + 1)}$, of M^m which satisfy the following properties:

$$(3.16) \quad U_i^j \cap U_k^j = \emptyset, \forall j = \overline{1, (m + 1)} \quad \text{and} \quad i \neq k,$$

and moreover U_i^j is diffeomorphic to an open ball for all i, j . Since U_i^j satisfy the condition (3.16), for a fixed j we can embed the union $\hat{U}^j = \cup_i U_i^j$ into \mathbb{R}^m . Thus for each j on the union \hat{U}^j we have local coordinates $x_j^r, r = \overline{1, (m + 1)}$, $j = \overline{1, (m + 1)}$. Using partition of unity functions $f_j(z)$ corresponding to \hat{U}^j we can write

$$g_1(z) = \sum_{j=1}^{m+1} f_j(z) \cdot \sum_{1 \leq r_1 < r_2 < \dots < r_k \leq m+1} \mu_j^{r_1 r_2 \dots r_k}(z) \cdot dx_j^{r_1} \wedge dx_j^{r_2} \wedge \dots \wedge dx_j^{r_k},$$

where the last coordinate x_j^{m+1} corresponds to the direction which is transversal to $T_z \hat{U}^j$ in $\hat{U}^j \times (-1, 1) \subset M^{m+1}$. We numerate (i.e. find a function θ with values

in \mathbb{N}^+) on the set $\{(j, r_1 r_2 \cdots r_k)\}$ of $N_1 = (m+1) \cdot \binom{m+1}{k}$ elements. Next we find a section s_2 of the form

$$s_2(z) = (\tilde{s}_1(z), \dots, \tilde{s}_{N_1}(z)), \tilde{s}_q(z) \in \text{Hom}(T_z M^{m+1}, \mathbb{R}_q^k)$$

such that

$$\begin{aligned} \tilde{s}_{\theta(j, r_1 r_2 \cdots r_k)}(z) &= f_j(z) \cdot \mu_j^{r_1 r_2 \cdots r_k}(z) \cdot A_{r_1, r_2, \dots, r_k}, \\ \text{where } A_{r_1, r_2, \dots, r_k}(\partial x_{r_l} \in T_z M^{m+1}) &:= \delta_l^i e_i \in \mathbb{R}_q^k. \end{aligned}$$

Here (e_1, e_2, \dots, e_k) is a vector basis in \mathbb{R}_q^k for $q = \theta(j, r_1 r_2 \cdots r_k)$ and (∂x_{r_l}) a basis in $T_z M^{m+1}$ defined via embedding $\tilde{U}_j \rightarrow \mathbb{R}^m$ as above. Clearly the section s_2 satisfies the condition $s_2^*(\beta^k(z)) = g_1(z)$ for all $z \in M^m$. This completes the second step.

Step 3. We put

$$s = (s_1, s_2),$$

where s_1 is the constructed section in Step 1 and s_2 is the constructed section in Step 2. Clearly s satisfies the condition of Lemma 3.13. \square

Proposition 3.7 now follows from Proposition 3.10 and Proposition 3.12.

3.17. Final remark. We conjecture that the isometric embedding map \tilde{f} in Theorem 3.6 is unique up to homotopy. It is the case, if ϕ^k is a closed stable form on M^m (i.e. the orbit of $GL_x(T_x M^m)(\phi^k)$ is dense in the space $\Lambda_x^k(T^*M)$ for all $x \in M^m$, see [6] for more information).

APPENDIX

A SOFT PROOF OF THE EXISTENCE OF A UNIVERSAL SPACE

For readers' convenience, we present here an elementary proof of the following

A.1. Theorem. *For any given positive integers n, k there exists a smooth manifold \mathcal{M} of dimension $N(n, k)$ and a closed differential k -form α on it with the following property. For any closed differential k -form ω on a smooth manifold M^n such that $[\omega] \in H^k(M^n, \mathbb{Z})$ there is a smooth embedding $f : M^n \rightarrow \mathcal{M}^{N(n, k)}$ such that $f^*(\alpha) = \omega$.*

Proof. As in the proof of Theorem 3.6 we reduce this problem to the existence of an immersion of M^n to the space \mathbb{R}^{N_1} with the constant k -form β_{N_1} such that the pull-back of β_{N_1} is equal to a given exact k -form g . Since g is an exact form there exists a $(k - 1)$ -form ϕ on M^n such that $d\phi = \omega$.

Next we use the Nash trick of a construction of an open covering A_i on M^n

$$(A.2) \quad M^n = \cup_{i=0}^n A_i,$$

such that each A_i is the union of disjoint open balls $D_{i,j}$, $j = 1, \dots, J(i)$ on M^n . (Pick a simplicial decomposition of M^n and construct A_i by the induction on i . Let $D_{0,j}$ be a small coordinate neighborhood of the j -th vertex. We may assume that they are mutually disjoint. Set $A_0 = \cup_{j=1}^{J(0)} D_{0,j}$. Suppose that A_0, \dots, A_i are defined. Let $D_{i+1,j}$ be a small coordinate neighborhood, which contains $S_j^{i+1} \setminus \cup_{\ell=0}^i A_\ell$, where S_j^{i+1} is the j -th $i + 1$ -dimensional simplex. We may assume that they are mutually disjoint. Set $A_{i+1} = \cup_{j=1}^{J(i+1)} D_{i+1,j}$. Hence we obtain desired open sets A_0, \dots, A_n .)

Let $\{\rho_i\}$ be the partition of unity on M subordinate to the covering $\{A_i\}$. We write $\phi(x) = \sum_{i=0}^n \rho_i(x) \cdot \phi$. Note that $\omega = d\phi = \sum d\phi_i$. Clearly the form $\phi_i = \rho_i(x) \cdot \phi$ has support on A_i .

Let $N_1 = \binom{n}{k-1}$ and

$$\gamma = \sum_{j=1}^{N_1} x_j^1 dx_j^2 \wedge \dots \wedge dx_j^k.$$

Note that $j = 1, \dots, \binom{n}{k-1}$ are in one-to-one correspondence with the sequences $1 \leq i_2 < \dots < i_k \leq n$.

A.3. Proposition. *There is an immersion $f_i : A_i \rightarrow (\mathbb{R}^{N_1 k}, \gamma)$ such that $f_i^*(\gamma) = \phi_i$. In particular, $f_i^* d\gamma = d\phi_i$.*

Proof of Proposition A.3. Since A_i is a union of the disjoint balls $D_{i,j}$ it suffices to prove the existence of immersion f_i on each ball $D = D_{i,j}$. Take some coordinate

(x_1, \dots, x_n) on the ball D . We can write the restriction of the $(k - 1)$ -form ϕ_i to D as ϕ , where

$$\phi(x) = \sum_{1 \leq i_2 < \dots < i_k \leq n} \lambda_{i_2 \dots i_k} dx^{i_2} \wedge \dots \wedge dx^{i_k}.$$

We construct map f_i as follows

$$(A.4) \quad f_i(x) = (\dots, f_{i; i_2 \dots i_k}(x), \dots)_{1 \leq i_2 < \dots < i_k \leq n}$$

where for $x = (x_1, x_2, \dots, x_n)$ we put

$$\begin{aligned} f_{i; i_2 \dots i_k}(x) : D &\rightarrow \mathbb{R}_{i_2 \dots i_k}^k(x^1, x^2, \dots, x^k), \\ (x_1, \dots, x_n) &\mapsto (x^1 = \lambda_{i_2 \dots i_k}(x), x^2 = x^{i_2}, \dots, x^k = x^{i_k}). \end{aligned}$$

Clearly we have $f_i^*(\omega) = \phi$. It is easy to check that f_i is an immersion on D . \square

We shall use cut-off functions χ_i with support contained in $A_i \subset M$ such that $\chi_i = 1$ on the support of ρ_i . Then $\tilde{f}_i = \chi_i \cdot f_i$ can be extended to the whole M^n .

Now we construct an immersion $f : M^n \rightarrow \mathbb{R}^{\overline{N_1}} = \mathbb{R}^{N_1 k(n+1)}$ by setting

$$(A.5) \quad f(x) = (\tilde{f}_0, \dots, \tilde{f}_n).$$

Clearly f is an immersion such that $f^*\alpha = \omega$.

Finally we note that we can choose $f : M^n \rightarrow \mathbb{R}^{\overline{N_1}}$ such that its image is contained in an arbitrary small neighborhood of the origin. It suffices to construct immersion \tilde{f}_i in (A.5) such that the image of \tilde{f}_i is contained in an arbitrary small neighborhood of the origin. Since \tilde{f}_i is constructed from immersion of ball D_{ij} with help of cut-off function χ_i such that $|\chi_i| \leq 1$ we reduce this problem to construct f_i whose image lies in arbitrary small neighborhood of origin. We do it by refining a given covering D_{ij} of M^n and modifying an immersion f satisfying the condition of Theorem A.1.

Choose $R > 0$ such that the image of f is contained in the R -ball centered at the origin $O \in \mathbb{R}^{\overline{N_1}}$. For a given integer m , we pick a refinement $\{V_p\}$ of the covering $\{D_{i,j}\}_{i,j}$ such that $f_{i(p)}(V_p)$ is contained in a ball of radius $1/m^2$. (The center of the ball may not be the origin.) Here $i(p)$ is chosen so that $V_p \subset A_{i(p)}$, i.e., there is $j(p)$ such that $V_p \subset D_{i(p),j(p)}$. Applying the Nash trick again to refine $\{V_p\}$ so that there is an open covering $\{A'_l\}$ of M such that each of A'_l is a union of some mutually disjoint family of V_p 's. On $V_p \subset A'_l$ we modify the construction of the mapping $f_{i; i_2, \dots, i_k}$ as follows. Using the translation in x_2, \dots, x_k -coordinates in each $\mathbb{R}_{i_2, \dots, i_k}^k$, we may assume that

$$f_{i; i_2, \dots, i_k}(V_p) \subset [-R, R] \times [-1/m^2, 1/m^2] \times \dots \times [-1/m^2, 1/m^2].$$

Now we consider the mapping

$$\Phi_m : (x_1, x_2, \dots, x_k) \mapsto \left(\frac{x_1}{m}, m \cdot x_2, x_3, \dots, x_k\right).$$

Then we find that $\Phi_m^* dx^1 \wedge \dots \wedge dx^k = dx^1 \wedge \dots \wedge dx^k$ and

$$\Phi_m \circ f_{i; i_2, \dots, i_k}(V_j) \subset [-R/m, R/m] \times [-1/m, 1/m] \times [-1/m^2, 1/m^2] \times \dots \times [-1/m^2, 1/m^2].$$

Clearly the modified map \tilde{f}_i with components $\tilde{f}_{i;i_2,\dots,i_k}(V_j) := \Phi_m \circ f_{i;i_2,\dots,i_k}(V_j)$ (see (A.4) for definition of f_i) together with the new refined partition of A_i as above has its image contained in an arbitrary small neighborhood of origin by taking m arbitrary large. \square
