# EVOLUTIONARY VARIATIONAL INEQUALITIES AND APPLICATIONS IN PLASTICITY

## INTRODUCTION

This paper concerns an abstract mathematical theory of evolutionary variational inequalities of two different types motivated by the classical flow theory of plasticity. The quasi-statical traction boundary value problems in infinitesimal strain approach for elastic-plastic bodies both with and without strain hardening are presented as examples.

The mathematical theory of plasticity leads to variational inequalities. Duvaut Lions [1] have proved existence of solutions of these inequalities for materials without hardening. However, in the quasi-statical case of the traction boundary value problem their assumptions are too strong, thus restricting essentially the applicability of the theorem.

To our knowledge the existence proof for the boundary value problem for elastic plastic materials with hardening has not yet been accomplished. From the physical point of view this case has been discussed by Nguyen [2]. By means of the here introduced plastic potencial, Nguyen formulates the problem as an evolutionary variational inequality. In comparison with parabolic variational inequalities there is no coercive elliptic term in Nguyen's inequality.

In the course of the proof-reading we have got acquainted, before its publication, with the paper [3] by Dr. K. Gröger, who solves a similar problem by formulating it as a parabolic inequality. The main difference between our treatment and that of Dr. K. Gröger is his assumption of nondegenerative kinematic hardening.

In our paper we use the penalty method to prove existence theorems for inequalities of Nguyen's type. It is interesting that the equation with a penalty term has the physical meaning of artificial viscosity with internal variables. With some caution we can say that the above mentioned penalty method is also of constructive character. For related problems see the papers [4], [5], [8], [9] and the book [10]. For general questions, see the book [6].

## PRELIMINARIES

In this section we collect the mathematical notation, definitions and assertions used later. The proofs can be found in [11].

Let $H$ be a Hilbert space with a scalar product $[., .]_{H}$ and a norm $\|., .\|_{H}=$ $=[., .]_{H}^{1 / 2}, V$ a closed subspace of $H, V^{\perp}$ the orthogonal complement of $V$ in $H$ and $P_{V}: H \rightarrow V$ the orthogonal projection on $V$.

Denote by $C([0, T], H)$ the space of all continuous functions $\sigma:[0, T] \rightarrow H$ with the scalar product

The closure of $C([0, T], H)$ with respect to the norm $\|\cdot\|_{L_{2}((0, T), H)}$ is denoted by $L_{2}((0, T), H)$. It is a Hilbert space of Bochner strongly measurable and square integrable functions $\sigma:(0, T) \rightarrow H$. Let $\sigma \in C([0, T], H), t \in[0, T]$. We define

The closure of $C^{1}([0, T], H)$ or $C_{0}^{1}([0, T], H)$ with respect to the norm $\|\cdot\|_{H^{1}}$ or $\|\cdot\|_{H_{0}{ }^{1}}$ is denoted by $H^{1}((0, T), H)$ or $H_{0}^{1}((0, T), H)$ (briefly $H^{1}$ or $\left.H_{0}^{1}\right)$, respectively. $H^{1}$ or $H_{0}^{1}$ is a Hilbert space with respect to the scalar product $(., .)_{H^{1}}$ or $(., .)_{H_{0}{ }^{1}}$, respectively. $\|\cdot\|_{H^{1}},\|\cdot\|_{H_{0}{ }^{1}}$ represent equivalent norms on $H_{0}^{1}$. Let $\sigma \in H^{1}$ or $H_{0}^{1}$,
$\sigma_{n} \in C^{1}$ or $C_{0}^{1}, \sigma_{n} \rightarrow \sigma$ in $H^{1}$ or $H_{0}^{1}$, respectively. The time derivative $\dot{\sigma}$ of $\sigma$ is defined by $\dot{\sigma} \equiv \lim \dot{\sigma}_{n}$ in $L_{2}((0, T), H)$. To $\sigma \in H^{1}$ there exists $\tilde{\sigma} \in C([0, T], H)$ such that $\sigma(t)=\tilde{\sigma}(t)$ a.e. on $[0, T]$. In this paper we use only these continuous representants $\tilde{\sigma}$ of the elements $\sigma \in H^{1}$. Let $\sigma, \tau \in H^{1}, t_{1}, t_{2} \in[0, T]$. Then

If a sequence $\sigma_{n} \in H^{1}$ or $H_{0}^{1}$ converges weakly to $\sigma$ in $H^{1}$ or $H_{0}^{1}$, respectively: $\sigma_{n} \rightarrow \sigma$, then $\sigma_{n}(t) \rightarrow \sigma(t)$ weakly in $H$ for all $t \in[0, T]$.

Denote by $W^{1,2}(G)$ the Sobolev space

Here $G$ is a bounded domain, $G \subset R^{3}$. Let $S$ be the Hilbert space of all symmetric tensor functions $\sigma=\left\{\sigma_{i j}\right\}_{i, j=1,2,3}, \sigma_{i j}=\sigma_{j i}, \sigma_{i j} \in L_{2}(G)$ with the scalar product

and the norm $\|\cdot\|_{S} \equiv(., .)_{S}^{1 / 2}$ (throughout the whole paper the summation convention is used). The formula

defines a tensor function $\varrho:\left[W^{1,2}(G)\right]^{3} \rightarrow S$. Let $\mathscr{K}$ denote the range of $\varrho$ and $\mathscr{H}$ the orthogonal complement of $\mathscr{K}$ in $S$. It is well known that $\mathscr{K}$ and $\mathscr{K}$ are closed subspaces of $S([4],[5])$.

Let $\tilde{S}$ be the space of all symmetric tensors $\sigma=\left\{\sigma_{i j}\right\}_{i, j=1,2,3}, \sigma_{i j}=\sigma_{j i}, \sigma_{i j} \in R^{1}$ with the scalar product $(\sigma, \tau)_{\tilde{S}}=\sigma_{i j} \tau_{i j}$ and the norm

We conclude this section with a trivial lemma.
Lemma. Let $u_{n} \in L_{\infty}((0, T) \times G),\left|u_{n}\right| \leqq C<\infty, u_{n} \rightarrow u$ pointwise a.e. on $(0, T) \times$ $\times G, v_{n} \in L_{2}((0, T), S), v_{n} \rightarrow v$ weakly in $L_{2}((0, T), S)$; then $u_{n} \cdot v_{n} \rightarrow u . v$ weakly in $L_{2}((0, T), S)$.

## ABSTRACT THEORY I

In this section we present in the abstract form a special type of evolutionary variational inequality. Its form is motivated by the boundary value problem for elastic-plastic material without hardening (this is shown in the section "Example I"). We first formulate a certain abstract problem and then prove uniqueness, existence and convergence theorems concerning the solution of this problem.

Let $K$ be a convex closed subset of $H$ and let $\theta \in C_{0}^{1}([0, T], H)$.
Problem I. Find $\sigma \in H_{0}^{1}$ such that for all $t \in[0, T]$,

\end{gather*}

\begin{gather*}
\int_{0}^{t}[\dot{\sigma}, \tau-\sigma]_{H} \mathrm{~d} s \geqq 0 \text { for all } \tau \in H_{0}^{1} \text { for which }  \tag{3}\\
\tau(s)-\theta(s) \in V \text { for all } s \in[0, T] \\
\tau(s) \in K \quad \text { for all } \quad s \in[0, T] .
\end{gather*}
$$

Theorem 1. There exists at most one solution of Problem I.
Proof. Let $\sigma^{1}, \sigma^{2}$ be two solutions. Taking $\sigma=\sigma^{1}, \tau=\sigma^{2}$ or $\sigma=\sigma^{2}, \tau=\sigma^{1}$ in (3), we obtain

Theorem 2. If there is a functional $g$ defined on $H$ such that
(4) the Fréchet derivative $g^{\prime}$ exists and it is monotone:

and Lipschitz continuous:

g(0) & =0 \tag{8}

and there is $\gamma>0$ such that

then there exists a solution of Problem I.
Proof. Let $\varepsilon_{n}$ tend to zero through some sequence of positive numbers: $\varepsilon_{n} \rightarrow 0+$, $\varepsilon_{n}>0$. For each $\varepsilon_{n}$, (4) implies the existence of a unique solution $\mu_{n} \in C_{0}^{1}([0, T], V)$ of the equation

Put $\sigma_{n} \equiv \mu_{n}+\theta$. Then

\text { and all } \tilde{\tau} \in V .
\end{gather*}
$$

Let us remark that by (11) we have

Taking $\tilde{\tau} \equiv \gamma\left(\dot{\sigma}_{n}-\dot{\theta}\right)+\left(\sigma_{n}-\theta\right) \in C([0, T], V)$ in (11), then integrating (11) over ( $0, t$ ), using (7), the formula

and the fact that $\theta+\gamma \dot{\theta} \in K$, we get

\quad+\frac{1}{\varepsilon_{n}} \int_{0}^{t}\left[g^{\prime}(\theta+\gamma \dot{\theta}), \theta+\gamma \dot{\theta}-\sigma_{n}\right]_{H} \mathrm{~d} s- \\
-\frac{1}{\varepsilon_{n}} \int_{0}^{t}\left[g^{\prime}\left(\sigma_{n}\right), \theta+\gamma \dot{\theta_{\varepsilon}}-\sigma_{n}\right]_{H} \mathrm{~d} s=\int_{0}^{t}\left[\dot{\sigma}_{n}, \theta+\gamma \dot{\theta}\right]_{H} \mathrm{~d} s
\end{gathered}
$$

Using monotonicity and the inequality $2 a b \leqq(1 / \xi) a^{2}+\xi b^{2}, \forall \xi>0$, we get for some constant $C>0$ the estimate

This estimate implies the existence of an element $\sigma \in H_{0}^{1}$ and a subsequence (again denoted by $\sigma_{n}$ ) convergent to $\sigma$ weakly in $H_{0}^{1}: \sigma_{n} \rightarrow \sigma$. It follows that $\sigma_{n}(t) \rightarrow \sigma(t)$ weakly in $H$ for all $t \in[0, T]$. Further, since $g$ is weakly lower semicontinuous due to its monotonicity, (13) implies $g(\sigma(t))=0$ for all $t \in[0, T]$. Hence we see that (2) is satisfied. Since $V$ is closed, we obtain also (1). It remains to show (3). From (11) and (7) it follows that

for all $\tau \in H_{0}^{1}$ such that $\tau(s)-\theta(s) \in V, \tau(s) \in K$ for all $s \in[0, T]$. By monotonicity and (14) we have

\end{equation*}

Using (15) we see that

& \leqq \int_{0}^{t}[\dot{\sigma}, \tau]_{H} \mathrm{~d} s-\frac{1}{2}\|\sigma(t)\|_{H}^{2}=\int_{0}^{t}[\dot{\sigma}, \tau-\sigma]_{H} \mathrm{~d} s .
\end{aligned}

This completes the proof of Theorem 2.
Theorem 3. Let $\sigma_{n}, \sigma$ denote the approximate solutions from the proof of Theorem 2 and their weak limit, respecively. Then we have $\sigma_{n} \rightarrow \sigma$ strongly in $C([0, T], H)$.

Proof. Taking $\tau=\sigma$ in (15), we get

Since $\sigma_{n} \rightarrow \sigma$ weakly in $H_{0}^{1}$, we have $\sigma_{n} \rightarrow \sigma$ weakly in $L_{2}((0, T), H)$. Put

The sequence of the functions $\psi_{n}$ is pointwise convergent to zero and uniformly bounded on $[0, T]$. It is

and by the Lebesgue Theorem we get $\sigma_{n} \rightarrow \sigma$ strongly in $L_{2}((0, T), H)$. It follows from (16) that

\frac{1}{2}\left\|\sigma_{n}(t)-\sigma(t)\right\|_{H}^{2} \leqq \int_{0}^{T}\left\{\|\dot{\sigma}(s)\|_{H} \cdot\left\|\sigma(s)-\sigma_{n}(s)\right\|_{H}\right\} \mathrm{d} s \leqq \\
\leqq\|\sigma\|_{H_{0}{ }^{1}} \cdot\left\|\sigma-\sigma_{n}\right\|_{L_{2}((0, T), H)} .
\end{gathered}
$$

This implies that $\sigma_{n} \rightarrow \sigma$ strongly in $C([0, T], H)$.

## EXAMPLE I.

As an example of application of Abstract theory I we study in this section the traction boundary value problem for an elastic-plastic material without hardening in infinitesimal strain approach. First we show a motivation of the definition of a weak solution of this problem. In this consideration we suppose the functions $\varepsilon, e, p, \sigma, \lambda$ introduced below to belong to or to have components from $C^{1}([0, T]$, $\left.L_{2}(G)\right)$. Let us consider a body in the time interval [0,T] occupying at time $t=0$ a bounded domain $G \subset R^{3}$ with lipschitz boundary $\partial G$. Let $u$ denote the vector of the displacement field at a fixed time $t \in[0, T]$. The strain tensor $\varepsilon$ is defined by

\end{gathered}
$$

Denote by $e, p$ the elastic and plastic parts of $\varepsilon$, respectively, and suppose that

\varepsilon_{i j}=e_{i j}+p_{i j} \text { for all } t \in[0, T], \text { a.e. on } G . \tag{17}
\end{equation*}
$$

The constitutive equations for $e$ and $p$ are supposed to be of the form

\dot{p}_{i j}=\hat{\lambda} \frac{\partial f}{\partial \sigma_{i j}}(\sigma) ; \tag{19}

here $\hat{\lambda}$ and $\sigma$ are such that $\hat{\lambda}=0$ for $f(\sigma)<k, \hat{\lambda} \geqq 0$ for $f(\sigma)=k, f(\sigma) \leqq k$ in the course of deformation ( $k$ is a constant), $\sigma$ denotes the stress tensor, $\hat{\lambda}$ is an undetermined nonnegative function and $f$ is the so called plasticity function. We suppose $f$ to be a convex function on $\widetilde{S}$ with bounded first and second partial derivatives, such that $f(0)<k$ and if $f(\tau) \geqq k$, then

Let $M_{i j k l}$ denote elasticity coefficients of Hook's law such that

& C_{1}\|\tau\|_{\tilde{S}}^{2} \leqq \tau_{i j} M_{i j k l}(x) \tau_{k l} \leqq C_{2}\|\tau\|_{\tilde{S}}^{2}  \tag{21}\\

## ABSTRACT THEORY II.

In this section we consider a problem similar to Problem 1. It is motivated by the boundary value problem for elastic-plastic material with isotropic hardening. We use the same notation as in Abstract theory I except the symbols $g$ and $K$. Let $L$ be a Hilbert space with the scalar product $(., .)_{L}$ and the norm

Problem II. Find $\sigma \in H_{0}^{1}\left((0, T), \alpha \in H^{1}((0, T), L)\right.$ with $\alpha(0)=\alpha_{0}$ satisfying for all $t \in[0, T]$ the conditions

Theorem 5. There exists at most one solution of Problem II.
Proof. The proof is almost the same as that of Theorem 1.
Theorem 6. If there is a functional $g$ defined on $H \times L$ such that

e) $\varepsilon(t)=e(t)+p(t)$ is a compatible tensor for all $t \in[0, T]$,
f) $\alpha(t, x)=\max \left(h^{1 / 2}(x) k, \max _{0 \leqq s \leqq t} h^{1 / 2}(x) f(\sigma(s, x))\right)$ a.e. on $G$, for all $t \in[0, T]$.

Proof. a) and b) can be proved in the same way as Theorem 3. The linearity of $e=\hat{M} \sigma$ implies c). Using Lemma from the end of Preliminaries and putting

we find d); note that the first derivatives of $f$ are bounded and $\sigma_{n} \rightarrow \sigma, \alpha_{n} \rightarrow \alpha$ pointwise on $(0, T) \times G$ by the just proved assertions a), b). We can see immediately that $\varepsilon_{n}(t) \rightarrow \varepsilon(t)$ weakly in $S$ and (68) implies e). It remains to prove f). Put

$$
\begin{aligned}
\tilde{f}(\sigma) \equiv h^{1 / 2} f(\sigma), & \tilde{k} \equiv h^{1 / 2} k, \\
\hat{n}(t, x) \equiv \max (\tilde{k}(x), & \left.\max _{0 \leqq s \leqq t} \tilde{f}(\sigma(s, x))\right) .
\end{aligned}
$$

Since $\tilde{f}, \hat{n}, \alpha \in H^{1}\left((0, T), L_{2}(G)\right)$, we find that the functions

$$
\begin{gathered}
f_{x}(t) \equiv \tilde{f}(\sigma(t, x)), \quad n_{x}(t) \equiv \tilde{n}(t, x), \\
\alpha_{x}(t) \equiv \alpha(t, x)
\end{gathered}
$$

are absolutely continuous on $[0, T]$ a.e. on $G$. It is

$$
n_{x}(0)=\alpha_{x}(0)=\tilde{k}(x), \quad \dot{\alpha}_{x} \geqq 0, \quad \dot{n}_{x} \geqq 0, \quad f_{x} \leqq \alpha_{x} \quad \text { on } \quad[0, T] .
$$

Take a fixed $t \in\left[0, T^{\prime}\right]$.
It is either $f_{x}(t)=n_{x}(t)$ and consequently $n_{x}(t) \leqq \alpha_{x}(t)$, or $f_{x}(t)<n_{x}(t)$. In the latter case we have $\dot{n}_{x}(t)=0, \dot{\alpha}_{x}(t) \geqq 0$. Put $\bar{t} \equiv \sup \left(s \in[0, t] \mid f_{x}(s)=n_{x}(s)\right)$. Since $\dot{n}_{x}=0, \dot{\alpha}_{x} \geqq 0$ a.e. on $(\bar{t}, t)$ and $n_{x}(\bar{t}) \leqq \alpha_{x}(\bar{t})$, we obtain $n_{x}(t) \leqq \alpha_{x}(t)$.

Now we show that $n_{x}(t) \geqq \alpha_{x}(t)$ on [0,T]. In (62) put $\tau=\sigma, \beta=\tilde{n}$. It follows that: $n_{x}(s)<\alpha_{x}(s)$ implies $\dot{\alpha}_{x}(s)=0$. Put $\hat{t} \equiv \sup \left(s \in[0, t] \mid n_{x}(s)=\alpha_{x}(s)\right)$. Let $\hat{t}<t$. Then $0 \leqq \hat{t}<t, n_{x}(\hat{t})=\alpha_{x}(\hat{t})$ and on $(\hat{t}, t)$ it is $n_{x}(s)<\alpha_{x}(s)$. Hence $\dot{\alpha}_{x}(s)=0$ a.e. on $(\hat{t}, t)$. This implies that $\alpha_{x}(\hat{t})=n_{x}(\hat{t}) \leqq n_{x}(t)<\alpha_{x}(t)=\alpha_{x}(\hat{t})$, which is contradiction. Since this consideration is correct a.e. on $G$, we conclude that $f$ ) is proved.

## EVOLUČNÍ VARIAČNÍ NEROVNICE

A JEJICH APLIKACE V PLASTICITĚ.

V práci je studována abstraktní teorie evolučních variačních nerovnic motivovaných klasickou přírustkovou teorií plasticity. V existenčních důkazech se používá metoda penalisace. Jako příklady aplikace teorie jsou diskutovány hraniční úlohy pro elasticko-plastická tělesa bez zpevnění i se zpevněním deformací.
